EDICAID UPDATE: The Medicaid billing services (such as physical therapy, occupational therapy, etc.) provided by a RESA will be treated as a vendor service. All counties will be required to use the following coding for recording Medicaid claim processing services provided by a RESA: 11.XXXXX.X2911.592. For coding purposes, the counties will need to use Object 592. The program/function code will depend on the service being provided (PT, OT, etc.).

Because the RESAs will be treated like any other vendor for cost reporting purposes, the RESAs will now need to bill counties just like any other vendor, effective July 1, 2012: Hours Worked x Billable Rate.

Dr. Sarah Lee, WVDE SPL Specialist, and Pamela Butcher, RESA 4 Special Education Director, provided professional development on Support for Personalized Learning (SPL). The West Virginia SPL framework encourages flexible use of available resources to provide academic, social/emotional and behavioral support necessary to support learning that reaches all students. The instructional practices of SPL work together to provide a seamless system of support which will allow all students to sustain significant progress.



Rogers provided administrators with a list of the many professional development offerings and services provided by the staff of RESA 4 and thanked the attendees for their participation in the Summer Administrators Institute.

WHAT IS THE CHILD CARE FOOD PROGRAM?

The Child & Adult Care Food Program (CACFP) is a United States Department of Agriculture (USDA) program that provides reimbursement for nutritious meals and helps to develop positive eating habits for young children enrolled in family day care homes across the nation. The West Virginia Child Nutrition Office through sponsoring organizations across the state administers the CACFP.

RESA 4 hosted the Minute Menu West Virginia State Training on August 29th and 30th. Agenda items included Managing Home Visits, Focus on Nutrition, Identifying and Tracking Seriously Deficient Providers, Exporting Files and the Minute Menus Sponsor Support Website. In attendance were representatives from the WV Department of Education, Office of Child Nutrition, and sponsors throughout the state.



A seminar on Important Legal Considerations for the 2012-2013 School Year was presented by attorney **Howard Seufer**, **Jr**., who is a well-respected education law expert and a partner in law firm of Bowles, Rice, McDavid, Graff & Love, LLC.

The session included information on legislation enacted during the 2012 State legislative session, recent decisions of the West Virginia Supreme Court of Appeals, as well as recent decisions of the West Virginia Public Employees Grievance Board.



RESA 4 Regional School Wellness Specialist, Cara Phillips, provided an update on efforts to improve regional wellness. In addition to providing information on school wellness, Phillips updated the administrators on the Jason Flatt Act of 2012, requiring the West Virginia Center for Professional Development to provide professional development on the early warning signs and resources available to assist in suicide prevention.

RESA 4 21stCCLC Professional Development

The RESA 4 21st Century Community Learning Centers Afterschool Programs offered two days of professional development for site staff on September 19-20, 2012. Approximately 45 staff members participated. Various trainings were offered over the two-day period.

Project director Dana Thomas met with the site coordinators on Wednesday morning while other staff were trained in model rocketry by Todd Ensign from NASA or STEM activities from Kellie Dean of PCS Edventures. The site coordinators participated in a Cyberbullying presentation by the WV Statewide Afterschool Network (WVSAN) in the afternoon.

On Thursday morning, the participants were trained in the "Health Rocks" curriculum from the WVSAN or the Future Problem Solving Program, presented by Dana Thomas. In the afternoon, participants either received training in the use of materials from Barb English of the GeoMotion Group or on parent involvement and recruiting volunteers from the WVSAN.

The trainings were all well-received and the participants took away some very valuable information that can be used in working with the students and parents at their sites.

RESA 4 has three projects funded by 21stCCLC grants. Sound Track 21 is in its fifth and final year of funding. The project includes Ansted Elementary and New River Elementary (Fayette County), Craigsville Elementary (Nicholas), and Crichton and White Sulphur Springs Elementaries (Greenbrier). The Connections grant is in its fourth year and includes Braxton County High School, Valley High School of Fayette, and Webster County High School. The FAST (Fayette AfterSchool Time) grant includes Ansted Middle, Collins Middle, and Oak Hill High School.
